London Ashridge Circle Privacy Policy

General Data Protection Regulation (GDPR) Privacy

What information does the Circle ask for?

The information on the Application Form is required in order for a person to become a member of the London Ashridge Circle. The Circle is the data controller of such information and relies on contractual necessity to process that information and use it to carry out various activities in relation to membership including sending communications to members.

Non-members and Guests

When non-members or guests attend a Circle Supper Talk we ask them to sign the Visitors' Book and if they wish, to provide their contact details in order for them to receive communications about the Circle and our programme.

What information does the Circle share?

The London Ashridge Circle does not share personal data of our Members or Non-members or guests with any third party. The Circle maintains a Members' Contact List, which is accessible by Circle Committee members only, for administrative purposes.

Information from the Circle's application forms is stored on password protected secure systems. This information is retained during the period of membership and for a period of one year following a decision not to renew (in case of change of mind during that year).

What personal data can you change?

A member may contact the Circle by post or email to the Membership Secretary at any time to access, correct, erase, restrict or otherwise object to the information stored about that member. A member may also contact the Office of the Information Commissioner at any time to make a complaint about our data handling practices.
